6. Company will make three times site visits for franchisee office selection, 4th site visit onwards will be on chargeable basis.
7. Renovation and design of franchise office/outlet will be as per company's approved plan layout design only.
8. All the permission/NOCs/Certificates required from central/state government or any local authority will be solely arranged by client only, cost of the same will be borne by client.
9. In case of rejection/cancellation/termination or withdrawn of franchise ship, the applicant cannot reapply for the same for next one (1) year.
10. That franchise owner shall not involve directly/indirectly in any activity that harms the company's brand in the market.
11. Sharing company's confidential documents to public, without written approval is strictly illegal. In case franchise Owner found occupied in such activity will cause his/her franchise termination immediately.
12. In case the franchise owner violets any of the above mentioned terms, company shall terminate your franchise immediately.
